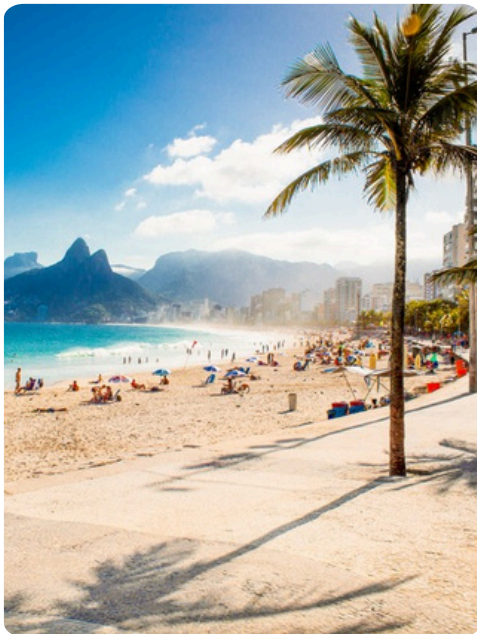



# What is a CPF and Why Do You Need One?

The Cadastro de Pessoas Físicas (CPF) is Brazil's version of a taxpayer ID—a simple 11-digit code issued by the Federal Revenue of Brazil (Receita Federal). But its importance goes far beyond taxes. Think of it as a key that unlocks access to essential financial and administrative systems in Brazil. So why do you need a CPF? In short, if you plan to live, work, or conduct business in Brazil, a CPF isn't just helpful it's essential. Here's why:

- **Open a Bank Account:** You'll need a CPF to start saving, transferring funds, or using Brazilian banking apps.
- **Rent an Apartment:** Most leases, even temporary ones require a CPF to finalize agreements.
- **Buy or Sell Property:** Investing in real estate? A CPF is mandatory to register property purchases.
- **Shop Online:** Many Brazilian e-commerce sites require a CPF, even for basic purchases like clothes or groceries.
- **Utilities & Services:** A CPF is needed to set up internet, electricity, or phone services.
- **Travel & Extras:** From booking a domestic flight to earning points in airline loyalty programs, your CPF is often requested.

Living without a CPF in Brazil is like trying to unlock doors without the right key. While tourists may get by without one, long-term residents and even short-term visitors will find life much easier with a CPF.

## What to Have Ready

### Ficha Cadastral de Pessoa Física (Individual Taxpayer Registration Form)



- Website link: [Ficha Cadastral de Pessoa Física](#)
- This form is required to initiate the online CPF application. It's an official registration document provided by Receita Federal.

### Declaração de Condição Fiscal (Declaration of Tax Situation)



- Website link: [Declaração de Condição Fiscal](#)
- This declaration confirms your tax status in Brazil and is an essential part of the application process.

### A scan of your passport



- Includes the photo and data pages.
- This serves as proof of your identity and nationality.

### A selfie holding your passport



- Ensure the passport details are visible in the photograph.
- This will be used to verify that the passport belongs to you.

### Confirmation email of the hotel you'll be residing in



- This confirms your local address for CPF registration purposes, which is required even if you're not a resident.

  - III - Documento de identidade do procurador e instrumento público de procuração, quando o pedido for efetuado por procurador.
- Obs.: O pedido de inscrição relativo a menor ou incapaz deverá ser assinado por um dos pais, pelo tutor, pelo curador ou pela pessoa responsável por sua guarda em virtude de decisão judicial.

- 3 After selecting your country, click the "FICHA" button at the bottom of the screen to move on to the next step in the form.

- If you're unsure, consider using a browser translation tool (such as Google Chrome's auto-translate feature).

### Check the "Inscrição" Radio Button

- This step confirms that you're registering for the CPF for the first time.

### Enter Your Complete Name

- Type your full name exactly as it appears on your identification documents.

### Select Your Gender

- Mark the box for "Masculino" (male) or "Feminino" (female).

### Enter Your Date of Birth

- Use the format day/month/year (e.g., "15/03/1995").
- Ensure the date matches what's on your official documents.

### Enter Your Mother's Name

- Include your mother's full name (e.g., first name, middle name, last name).

6

### Enter the Name of Your Street

- Provide the street name for your current residence (e.g., "Main Street" or "Riverside").

7

### Enter Your Building/Address Number

- Provide the house or building number associated with your street. "Complemento" would designate your apartment number. Otherwise leave blank.

8

### Enter Your City Name

- Type the name of your current city (e.g., "New York" or "Chicago").

9

### Select Your Nationality

- Use the dropdown menu to select your nationality.
- For Americans: Look for "Estados Unidos" in Portuguese.

10

### Enter Your Phone Number

- Start with your area code (e.g., "312...").

11

### Provide Your Email Address

- Enter a valid email address you can actively access for further communication.

12

### Enter the Last Day You Were in Brazil (Optional)

- If you've visited Brazil before, enter the last date you were there using the format day/month/year.
- If you've never been to Brazil, leave this field blank.

### Click "Enviar" to Proceed

# Quick Tips



Make sure your signature matches the signature style on your passport or official identification documents exactly. Any discrepancies in your signature could result in your application being rejected. Take your time to ensure consistency!

## Option 1: Print, Sign, and Scan

### 1. Print the Form

- Use your printer to create a physical copy of the filled out form.

### 2. Fill in the "LOCALIDADE" Field

- Under "LOCALIDADE" (Location), write the name of the city where you're signing the form (this is typically your current city of residence).

### 3. Sign the Form

- Below "ASSINATURA" (Signature), add your signature by hand and use black ink.

### 4. Scan and Save as a PDF

- Use a scanner or a mobile app (such as Adobe Scan, CamScanner, or similar apps) to scan the signed form.
- Save the scanned form as a PDF file for later use.

## Option 2: Digital Signing

### 1. Save or Print the Form to PDF

- Save the form as a PDF directly from the webpage using your browser's print function (e.g., File > Print > Save as PDF).

### 2. Sign Digitally on a Tablet, Smartphone, or Laptop

- Use a device with a stylus and a PDF editing app (e.g., Adobe Acrobat, DocuSign, or similar).
- Fill in the "LOCALIDADE" field by typing or handwriting the city name.
- Sign the "ASSINATURA" field using the stylus or touchscreen.



### 3. Save the Signed PDF

- Once the digital signature process is complete, save the PDF and store it securely until you finish the rest of the application.

### 7. Signature, Location & Date

- Next to the signature line, write the city where you're currently located, followed by today's date in day/month/year format.

#### 1. Fill in Your Full Name

- In the line following "Eu," write your complete name as it appears on official documents (e.g., passport).

#### 2. Enter Your Date of Birth

- In the space after "nascido(a) em," write your date of birth using the day/month/year format (e.g., 14/01/1993).

#### 3. Provide Your Nationality

- After "de nacionalidade," write your nationality (e.g., "americana" for American, "canadense" for Canadian, etc.).

#### 4. Enter Your Parents' Names

- After "filho de," enter your father's full name (e.g., John Doe).
- After "e," enter your mother's full name (e.g., Mary Smith).

#### 5. Address of Residence (or Hotel)

- In the space following "resido no endereço," fill in the address of your hotel or Brazilian residence.

#### 6. Select the Non-Residency Status

- Check the radio button next to "não-residente no Brasil, nos termos do art. 3º da Instrução Normativa SRF nº 208/2002" to confirm you're declaring non-residency in Brazil.

# Passport Scan & Selfie with Passport Instructions

At this step, you will need two essential pieces of documentation to verify your identity:

- Position yourself in a well-lit area.
- Avoid blurry or overly dark images; the passport details should be easy to read.
- Hold the passport close to your face but without blocking your photo.
- Ensure the passport is fully visible and not cropped out of the frame.



## Passport Scan

### What to do:

- Provide a clear, high quality scan or photo of your passport.
- Ensure that the following details are fully visible and legible:
  - Full name
  - Passport number
  - Date of issue and expiration
  - Photo and personal details (e.g., birth date, nationality).
  - Signature

- Use good lighting to avoid glare or shadows on the passport.
- If scanning, set the resolution to at least 300 DPI for maximum clarity.
- Save the image or scan in PDF (preferred) or JPEG format.



## Selfie Holding Your Passport

### What to do:

- Take a clear selfie while holding your passport open to the identification page (the page with your photo and personal details).
- Make sure both your face and the passport details are visible and legible in the photo.



# Recap and Checklist

Use this checklist to confirm all required documents are complete and organized before you submit your application. Missing or incorrect documents could delay the process, so double check everything!



## Ficha Cadastral de Pessoa Física

- Your Ficha Cadastral de Pessoa Física (FCPF) form must be:
  - Fully filled out with accurate personal details.
  - Signed at the bottom to validate it.

## Declaração de Condição Fiscal

- Fully completed and signed.
- Includes:
  - Your name, date of birth, nationality, and parents' names.
  - Brazilian residential or hotel address.
  - Signature and location/date in dd/mm/yyyy format.

## Passport Scan

- A high-resolution scan/photo of the identification page of your passport.
- Ensure all details are clearly legible, including:
  - Your name.
  - Signature.
  - Passport number.
  - Date of Issue and Expiration.
  - Photograph.

## Selfie Holding Passport

- High-quality photo of you holding your passport.
- Make sure the ID page of the passport (with your name and photo), your face and your signature are completely visible and clear.

## Hotel Confirmation

- Hotel booking confirmation showing:
  - Your full name.
  - Hotel name and address.
  - Check-in and check-out dates.
  - Booking reference/confirmation number.



**Note:** If staying with a host (friends/family), substitute this with a letter of invitation that includes your host's address and contact details.



# SUBMITTING THE APPLICATION: STEP BY STEP INSTRUCTIONS

Now that all your documents are prepared, follow these steps to successfully submit your CPF (Cadastro de Pessoa Física) application:

## 1. Organize Your Files

Before sending your application, ensure your documents are properly organized:

- Save all required documents in the correct format: PDF is preferred, but JPEG is also acceptable.
- Ensure each file is less than 1MB in size to avoid delivery issues.
- Name your files clearly for easy identification. Examples of file names:
  - Ficha\_Cadastral.pdf
  - Passport\_Scan.pdf
  - Hotel\_Confirmation.pdf

*Tip: Double check that all documents are complete, accurate, and legible before proceeding.*

## 2. Prepare Your Email

- Open your email application (e.g., Gmail, Outlook, etc.).
- Compose a new email and attach all the files you've prepared.
- In the subject line, write: "Inscrição de CPF"
- In the body of the email, also write: "Inscrição de CPF"

Once your application is submitted, the processing time will typically take between 2–5 business days, unless there are any issues with your documents. If your application is approved, you'll receive your CPF via email.



## 3. Determine the Appropriate Email Address

The email address to send your application will depend on the region or state where you'll be residing in Brazil. Use the table below to find the correct email address based on your region:

## 4. Send and Wait

- After determining the correct email address, enter it into the recipient field of your email.
- Double check the email address, subject line, and attachments to confirm everything is accurate.
- Click send to finalize your submission.

## APPLICATION REJECTIONS

If your application is rejected or you receive an error message, review the email response for details. Corrections may include:

- Missing or incomplete documents.
- Incorrect document format or file size (e.g., over 1MB).
- File names that are not clear or descriptive.
- Review your documents carefully and re-submit after making the necessary changes.



## PRO TIP - Stick to PDFs Whenever Possible.

PDFs are preferred for better compatibility and to ensure document integrity. Convert scanned images to PDF using free online tools if needed.



## Can I check the status of my application?

There is no online status tracker. If you have waited more than 7 business days without a response, send a follow-up email to the regional address where you submitted the application.

## STAY ALERT FOR REPLIES IN SPAM/JUNK FOLDERS

Occasionally, responses may be filtered into these folders. Don't forget to check there if you haven't received a reply within the expected timeframe.

## PAY ATTENTION TO THE DETAILS

The response you receive regarding your CPF application will be in Portuguese, as it is the official language used by Brazilian authorities. If your application is denied, the email will provide a detailed explanation of the reason for rejection.

Once your application is approved, you will receive an email with the following message:

### What You'll Receive

The email will include two PDF files for download:

- Ficha Cadastral: This document contains your registration details with the Receita Federal.
- Comprovante de Inscrição CPF (CPF Card): Your official CPF certificate.

When you click on the download links, you'll be asked to verify your email address. Make sure to use the same email you used during the initial application. Once verified, the PDF file will open, allowing you to download and save the documents. Be sure to save your CPF files immediately, as they will only be available for a limited time.
